MARSH SPARROW BANDING BEGAN DURING THE WINTER OF 2011-12 WITH THE OBJECTIVE OF DETERMINING HABITAT REQUIREMENTS, SITE FIDELITY, RELATIVE ABUNDANCE AND DISTRIBUTION OF THE SPECIES. THE BIRDS ARE FLUSHED INTO MIST NETS AT HIGH TIDE ROOSTS IN THE SALT MARSH. THE TARGET SPECIES ARE SEASIDE SPARROWS, NELSON'S SPARROWS AND SALTMARSH SPARROWS. THE KIAWAH CONSERVANCY IS SUPPORTING A STABLE ISOTOPE RESEARCH PROGRAM TO LEARN MORE ABOUT THE BREEDING RANGE OF MARSH SPARROWS (IN CONJUNCTION WITH THE TOWN OF KIAWAH WILDLIFE BIOLOGIST AND COASTAL CAROLINA UNIVERSITY.
